Dr. John J. Abbatiello earned his PhD from King's College London's War Studies program in 2004. After 18 years of faculty service at the Air Force Academy's Department of History and Center for Character and Leadership Development, he then served as the Training and Education Branch Chief for North American Aerospace Defense Command and US Northern Command. He is the author of *Anti-Submarine Warfare in World War I: British Naval Aviation and the Defeat of the U-Boats* (Routledge, 2006) and a chapter on Lt Gen Lewis Brereton in *The Worst Military Leaders in History* (Reaktion Books, 2022). **September 25, 2026 (Friday) - Session I**

Dr. Jonathan Abel is an Associate Professor of Military History at the US Army Command and General Staff College, where he teaches courses on French history as well as Greece and Rome and wargaming. Dr. Geoff Babb was commissioned from Bowdoin College in Brunswick, Maine. He served as a US Army Military Intelligence Officer in Washington, DC and after completing education as a China Foreign Area Officer, was then assigned to Joint and Army Headquarters in Hawaii. He later was posted to the Command and General Staff College faculty at Fort Leavenworth where he works today in the Department of Military History. Dr. Brenden Bliss, Hawai'i Pacific University. Dr. Bliss is a military and naval historian with primary research interests in the 19th and 20th centuries. He graduated cum laude from Andrews University in 2001 with a BA in History. In 2003 he earned a Masters Degree in War Studies with Distinction from King's College London, followed in 2023 by a Doctorate of Philosophy in the same discipline also from King's. His thesis focus was on British naval power and its role in maintaining national influence in the Pacific, with special focus on Hawai'i, from 1800 - 1855. Dr. Jeffrey Foss, MD - Dr. Jeffrey Foss is a former U.S. Army Medical Corps physician who earned his master's degree and M.D. from Louisiana State University. His current research project, *Command Crisis in the Bulge: Eisenhower, Twelfth Army Group, and the Transfer of First and Ninth Armies to Montgomery*, examines Allied command decisions during the Battle of the Bulge. Dr. Sean N. Kalic is a Cold War historian. He lectures and publishes widely on topics such as U.S. space policy, the Cold War, the post-Cold War security environment, and transnational terrorism. Prior to CGSC, he taught at Youngstown State University, Kansas State University, and Norwich University. He has presented lectures for the U.S. Naval War College's Fleet Seminar Program, The Slovenian General Staff, The Slovenian Command and General Staff College, The U.S. Army's Futures Command, as well as numerous international conferences. Currently, he is a Professor and the Director of the Department of Military History at the US Army Command and General Staff College, where he has taught since 2004. Book publications include: *Combating a Modern Hydra: Al Qaeda and the Global War on Terrorism* (2005); *Thinking about War: Past, Present and Future* (2011); *US Presidents and the Militarization of Space, 1946-1967* (2012); *The Russian Revolution and Russian Civil War: An Essential Reference* (2017); and *Spies: The U.S. And Russian Espionage from the Cold War to the 21st Century* (2019). *U.S. Presidents During Wartime* (2023), and *The End of the Cold War and Its Aftermath* (2023). **September 26, 2026 (Saturday)** - Session IV A

Dr. Douglas B. Kennedy currently serves as an Assistant Professor in the USAFA Department of History, a position he's held since 2016, where he teaches military and American history. He is a 1989 graduate of the USAF Academy, a 1997 MA recipient from the University of Georgia, and earned his PhD from Kansas State University in 2017. He attended pilot training at Williams AFB, AZ and went on to an operational assignment in C-130s at the 50 th Airlift Squadron, Little Rock AFB, AR, with additional deployments and service in Saudi Arabia, Kenya, and Somalia. After receiving his MA, he had a follow-on assignment in the U.S. Air Force Academy Department of History. After serving with the 37 th Airlift Squadron in Germany, a stint with HQ Air Mobility Command at Scott, AFB, IL, and a deployment to Baghdad, Iraq in support of Operation Iraqi Freedom, he was selected to pursue doctoral education at Kansas State University. Originally a scholar of the Eisenhower era foreign policy, his dissertation explored the creation of the US Air Force Academy and the development of the professional military studies program. He returned to the Air Force Academy for a final tour, with additional duties in the 98 th Training Squadron flying the UV-18B Twin Otter supporting parachute operations, and a deployment to Afghanistan as the Joint Operations Director/Advisor to the Afghan Air Force while with the NATO Air Training Command-Afghanistan. He retired from the U.S. Navy in 2004 at the rank of commander after 23 years, serving as a naval flight officer flying land- and carrier-based aircraft. He has taught a variety of subjects, including military history, at the CGSC since 2000. His books include *Agents of Innovation: The General Board and the Design of the Fleet that Defeated the Japanese Navy* (2008); *Eyewitness Pacific Theater: Firsthand Accounts of the War in the Pacific from Pearl Harbor to the Atomic Bombs* (2008), coauthored with D.M. Giangreco; *A Military History of Japan: From the Age of the Samurai to the 21st Century* (2014); *Napoleonic Warfare: The Operational Art of the Great Campaigns* (2015); *America's First General Staff: A Short History of the Rise and Fall of the General Board of the U.S. Navy, 1900–1950* (2017), and *The 100 Worst Military Disasters in History* (2020), coauthored with David Holden. He has published numerous articles and editorials and was awarded a Moncado Prize by the Society for Military History in 2011. His 2022 article "Zumwalt, Holloway, and the Soviet Navy Threat Leadership in a Time of Strategic, Social, and Cultural Change," published in the *Journal of Advanced Military Studies* by Marine Corps University Press, received the Society for Military History's 2023 Vandervort Prize. **September 26, 2026 (Saturday) - Session VA**

Dr. Xiaobing Li is a Professor of History and Geography and the Don Betz Endowed Chair in International Studies at the University of Central Oklahoma (UCO). Born in Beijing, he served in the People's Liberation Army (PLA) before moving to the U.S. in 1983. He holds an M.A. and a Ph.D. from Carnegie Mellon University. Dr. Li joined the UCO faculty in 1993. A noted military historian and expert in East Asian studies, he also serves as the director of the Western Pacific Institute. He is a widely published author, having written and edited numerous books on Chinese military history, the Cold War, and the Vietnam and Korean Wars. **September 26, 2026 (Saturday) - Session VIA**

Dr. Jessica Luepke is a Lecturer at Texas State University, teaching US History. She earned her PhD in U.S. History from the University of North Texas in 2025. Dr. Luepke studies military history with a focus on U.S. martial culture, military interventions and occupations, imperialism, race, and gender. Dr. Luepke's dissertation investigated the occupations of the Philippines (1898-1902), Haiti (1915-1917), and Germany (1945-1946) to uncover why occupations change martial culture. In doing so, she established patterns that were influenced by national imperial aims, racial attitudes, and gender relations. She recently published an article, "Lust, Duty, and STDs: Fraternization and Disobedience in American-Occupied Germany, 1945-1946" in *Army History*, an institutional magazine for the U.S. Army's Center of Military History. Her future projects include an article on the occupation of Haiti (1915-1917) and the publication of her dissertation. Dr. David Mills is an associate professor of military history at the U.S. Army Command and General Staff College at Fort Leavenworth, Kansas. Dr. Mills spent ten years in the United States Army, including service in Desert Shield and Desert Storm, earning a Bronze Star. He was the recipient of a Fulbright Fellowship, having taught for a semester in the Russian Federation at Ufa University. He holds a doctorate from North Dakota State University and is the author of three books on military and Cold War history. His current research project examines the effort to feed Germany from the fall of Hitler through the Marshall Plan. **September 26, 2026 (Saturday) - Session IVA**

Dr. Rich Myrick is a military historian, retired U.S. Marine Corps Lieutenant Colonel, and was a James C. Carey Research Fellow at the Kansas State University Department of History in Manhattan, KS. He earned his Ph.D. from the university in 2023, specializing in early modern and modern European military and political history. Rich's dissertation focused on the foundation and legacy of a liberal and non-confessional Catholic political party active in France from 1901-1919. The subject fits into his broader interest in political, constitutional, and confessional movements in Early Modern and Modern Europe. He also studies eighteenth and nineteenth century naval history, with a specific research interest in the British and French naval forces of the Georgian Era. Ryan Neck, Doctoral student and Graduate Research Assistant in American Studies. He holds a B.A. in History from Samford University, and an M.A. in History from San Diego State University. He is also a U.S. Air Force veteran, having served as a Nuclear and Missile Operations Officer. His research interests focus on the intersection between race and empire within U.S. military history. Specifically, his current research focusses on how the construct of whiteness influenced American war plans in the early twentieth century, such as War Plan Orange for Imperial Japan and War Plan Red for the British Empire. Dr. Ethan Rafuse, is associate professor of military history at the U.S. Army Command and General Staff college at Fort Leavenworth, Kansas. Gideon Remez, Associate Fellow (Retired) Truman Institute, Hebrew University of Jerusalem headed the foreign news desk at the Voice of Israel. He is a fellow of the Harry S. Truman Research Institute for the Advancement of Peace at the Hebrew University of Jerusalem. Following a Bachelor's degree in Hebrew Linguistics and Literature and in Philosophy from the Hebrew University of Jerusalem ('73), Remez received a Master's degree in History of American Civilization ('78) from Brandeis University, Massachusetts. After retiring

from radio journalism in 2003, he joined the research project initiated by Dr. Isabella Ginor of the Truman Institute at the Hebrew University on the Soviet military involvement in the Arab-Israeli conflict. Jeff Schultz, Professor of History, Luzerne County Community College. Jeff has taught history and political science to community college undergraduates for over twenty years. He earned both an MA in history and another in political science from Central Michigan University. He specializes in military history; in particular, Second World War and the Cold War era. He has presented many history conference papers and is also the author of Chapter 12: 'The Reich strikes back: German victory in the Dodecanese, October–November 1943', in T. Heck and B. A.
